We are delighted to announce that the third EAHL conference is to be held on 6 & 7<sup>th</sup> October 2011. It is being hosted by the Centre for Biomedical Ethics and Law at the University of Leuven, Belgium.

## Update on European Health Law eCPD Course

The SCRIPT Centre at the School of Law, University of Edinburgh has been awarded funds to produce an online Continuing Professional Development module on European Health Law.

Thank to those of you who expressed an interest in contributing to the production of this course.

We are delighted to say that the module is now in the early stages of production. We envisage a stand-alone teaching module of 10 weeks to be administered through the Distance Learning office at the University of Edinburgh. The module will be offered at three levels: 1. As part of a Masters LLM degree, 2. as a stand-alone module for EAHL members and others interested in European Health Law (for which we would charge and funds would go to the EAHL) and, 3. possibly in the future, as a Continuing Professional Development module (on the same fee basis for EAHL).

We hope that this module will be an excellent opportunity to build capacity and to generate funds for the Association.

## Call for Applications

This year EAHL 2011 will be preceded by a satellite workshop for doctoral students and Early Career Researchers. The workshop will give attendees a unique opportunity to present on their work and to discuss with experts in the field. It will also provide a chance to get tips on how to make the most out of the EAHL conference 2011 and academic networking. This is a fully-paid initiative sponsored by the SCRIPT research centre in the School of Law, University of Edinburgh ([www.law.ed.ac.uk/ahrc](http://www.law.ed.ac.uk/ahrc)).

The workshop will take place on 5th October at the Law Faculty, University of Leuven.

There are only 20 places for this workshop and each successful applicant will receive all their travel, accommodation (for a maximum of 3 days) and registration for EAHL 2011.

Applications for this exciting opportunity are invited from all full-time PhD students or Early Career Researchers (maximum five years post-doctoral experience), who are registered or working in a European University. Applicants should submit an application form (available online) along with a covering letter of application, a 500 word abstract on one of the conference themes and provide proof of their PhD or ECR status. Successful applications will be judged by a panel of expert readers consisting of members of the EAHL Steering Committee. The criteria for success are the quality of the abstract and its ideas, relevance of the proposed paper to EAHL 2011 and the extent to which the paper reflects the objectives of the European Association of Health Law.



## WORKING GROUPS and INTEREST GROUPS

One of the main initiatives of the Association is to encourage and facilitate the exchange of research and knowledge of Health Law across Europe. 
